3M™ Scott™ X380 and X190 Thermal Imager Rechargeable Battery Care and Maintenance Update

Attention: 3M Distributors.

Dear valued customer,

3M Scott has updated its advice about the storage and maintenance of the rechargeable batteries in the aforementioned models (part numbers listed in the table below). This information should be used in conjunction with the advice contained in the User Instructions.

- Always inspect batteries before use.
- Ensure the battery is clean and dry prior to installing the battery into the camera or charger.
- To ensure long service life, it is recommended that batteries are stored between 14°C (58°F) and 30°C (95°F)
- The batteries should always be removed from the thermal imager before storage for extended periods.
- Never try to open or service a battery pack. There are no user serviceable parts in the battery pack.

In addition:

- We recommend batteries that are not used for extended periods be charged to at least 50% each month (two yellow LED on the battery status)
- We recommend batteries in storage be checked at least once a month for:
 - Level should be maintained at greater than 25% charge (one red LED on the battery status)
 - Damage
 - Corrosion or leakage
 - Functionality including in a charger and camera

If the battery is damaged, unable to maintain charge, fails to function correctly or fails one of the above criteria, remove the battery from service for proper disposal and replacement. Dispose of depleted or damaged batteries in accordance with local environmental regulations or return them to 3M Scott for safe disposal or repair/replacement. The User instructions contain details of how to return batteries.
